Berlin, April 27.—The American mem-bers of the commission to consider the questions concerning Samo: made a social call upon Prince Bismarck and Count Herbert Bismarck this afternoon and the delegates are delighted with the reception accorded them. The chancellor was specially cordial to Mr. Bates, who explained that his uticle on Samoa in the Century magezine was written long be-fore he was nominated a delegate to the conference, and that after his nomination he tried to withdraw the article; but in vain, as thousands of copies had been printed. Prince Bismarck showed perfeet familiarity with the Samo in question. He expressed the lope that the conference would be brief. He frequently referred to the diplomatic and parliamen-tary experience of Messrs, Kasson and Phelps The first sitting was held at 2.30 P. M. today at the foreign office.

The foreign office appears to be assured of an early termination of the negotiaof the early elementation of the negotia-tions. The commission, however, expects that the sittings will be protracted for several months, especially if the charges against Klein involving claims against the Washington government are brought up. Prince Bisinareli certainly intends to place the evidence of Herren Brandels and Knappe and others before the conference, but ne has abindoned the claims for indemnity arising from Klein's action. This concession ought to shorten proceed-

ags.
The claim against the Samoans for plundering German traders and planters will be maintained. There is reason to believe that England supports the principle of the German demands and it is trusted that the American delegates are empowered to admit it. The amount of the indemnity is not likely to give rise to any disagreement, being merely a question as to the accuracy of the claims presented.
