FORMER OAKLAND CO. BOY

Now Half Owner in Traver & Co.'s Business, Detroit.

Rarely indeed has a man made himself as well known and forced himself to the front by his ability among the most successful merchants of today as has S. L. Bird of Chicago, who recently purchased a half interest in the firm of B. H. Traver & Co., Detroit.




