NUTRITION
By IVA M. CHURCH

With the coming of summer it seems quite natural to think of fresh fruits and fresh vegetables. We consciously buy them mostly for their flavor, but nature has been most generous with us in that she has thrown in something more valuable than flavor. What did we get for nothing?

In the first place we are buying minerals. By minerals we mean the lime required for the building of teeth and bones, as well as the amount required for the coagulation of the blood, a safety provision without which small wounds would result in death by bleeding. Then too, we need iron for the building of good blood. Furthermore it is better to get these minerals from vegetables and fruits rather than from medicines as they are more easily utilized by the body. Not only do fruits and vegetables supply us with minerals, but they aid in the digestive processes by making the food more bulky. Also they are useful in giving us more water. We need a greater amount of water than most people are accustomed to drinking.

So far then we have found that these fruits and vegetables should be supplying our bodies with minerals, water and a certain amount of bulk, also another most important element called the vitamins, which will be treated in the following article. Have we really received these minerals or were they thrown down the sink? The vegetable water contains most of the minerals and for that reason should be served with the vegetable. Again we find that the mineral matter is often found in one part more than in another. In the potatoes, for instance, there is much of it in the layer next to the skin. This is why potatoes ought to be pared as thinly as possible, or if left the skin should also be eaten.

In order to receive our quota of minerals each day, it is necessary to serve one other vegetable besides potatoes, preferable of the green leaf variety such as spinach, dandelion, lettuce, turnip tops, raw cabbage, beans, sprouts etc. When these are not available there still remain carrots, turnips, etc. and the get-togethered during the summer. The young holds true of fruits. It is impossible to buy fresh fruits during the entire year there will remain the canned and dried fruits which greatly plentiful. However, it will be explained in the following article. It is better to have either one or two fruits of green vegetable to obtain with canned or dried fruits.

FORESTRY STUDENTS TO CAMP IN NORTHERN WOODS.

Scouting actual field conditions, and working closely with the practical life of forest rangers, students of forestry class at the Michigan Agricultural College will camp in the woods of Northern Michigan during the month of summer.

The young foresters will live in a log cabin camp on the grounds of the Auton Iron Company in Kalkaska County. Here they will put in a fashioned life, pack hoppers, bring the business of timber transport, land surveying, and logging from the ground up.

The camp which is an annual feature of the college work will be in charge of Prof. P. L. Buttrick and Prof. A. L. Garratt of the M. A. C. Forestry Department. Twenty students will be included in the camp roll all of whom are preparing to enter active service in the forestry profession.



COAL CONFERENCE CALLED BY HOOVER

NON-UNION OPERATORS ASKED TO CO-OPERATE TO AVERT FUEL CRISIS.

WAR TIME PLAN TO BE REVIVED

Hoover Suggests That District Committees Receive and Distribute Orders While Strike Lasts.

Washington—Administration plans for holding down soft coal prices were carried a step further Sunday when Secretary Hoover issued a general call for a conference of all the 1,500 coal operators whose mines are still producing. The conference is to be held in Washington, May 31.

The operators will be asked to approve and put into effect the scheme of creating district committees to receive and allocate all orders during the duration of the strike, and with co-operation from the Washington committee to prevent coal going into hands of speculators and middlemen who may unduly enhance prices.

Fifty operators controlling the bulk of present production and open shop production have pledged themselves to support the plan using the Garfield prices of the war-time fuel administration as a general basis from which to set up fair price standards.

This would establish mine prices of bituminous in a range of from \$2 to \$8 per ton.

Striking union miners have gone back in considerable numbers "only in southeastern Kentucky and Tennessee," according to a report of the geological survey, and the production figures generally suggest no marked change in the number of men on strike. Anthracite production, it was said, "remains at practically zero."

FAMILY FEUD COSTS TWO LIVES

One Man Shot, Other Dead From Shock; Woman Wounded.

Rawlins, Pa.—E. W. Baldwin and J. C. Geddes, are dead, Mrs. Baldwin seriously wounded and William Cole was taken to the county jail on a charge of murder, the result of a shooting affray Sunday afternoon following a long-standing feud between the Baldwins and Cole families over a fence.

After struggling with his neighbor for several minutes, Cole rushed into his home and got a loaded revolver, police declare. In a fight which followed, Baldwin was shot through the heart and killed. A shot hit Mrs. Baldwin, Cole, was overpowered by other neighbors.

Godwin an elderly man who had been suffering from heart attacks for several months, was watching the scene from his porch a couple hundred feet away when the fatal shot was fired. He was seen to fall from his chair to the floor and when members of his family reached his side he was dead.

SHIPS CRASH; MANY LIVES LOST

Collision Occurs Near French Coast; Dense Fog Blamed.

Brest, France—Nearly 130 persons perished Saturday night when the Peninsular and Oriental Line steamer Egypt sank off the Island of Ushat, after a collision with the French freight steamer Seine.

The collision occurred during a fog within 22 miles of the Armen lighthouse. The dinner gong was going was about to be sounded on board the Egypt. Many of the passengers and most of the crew were on deck. The shock threw several persons into the sea; others jumped and a number went down with the ship, which sank in 20 minutes. The Egypt was rammed amidships on the port side.

The Seine, badly damaged, reached Brest with 29 rescued passengers, more than 200 of the crew, and the bodies of 20 dead. The captain of the Egypt is among the saved.

FILM STAR ACCUSED OF BIGAMY

Rudolph Valentino in Meshes of Law; Out on Bail.

Los Angeles—Rudolph Valentino, motion picture hero, has been accused of bigamy, in a complaint issued by Deputy District Attorney McClelland, as the result of the actor's marriage on May 13 at Mexicali, Lower California, to Miss Winifred Hudnut.

Bail was fixed at \$10,000 in bonds and \$5,000 in cash which was immediately furnished. The hearing is set for June 1.

Mr. Valentino was married to Jean Acker in 1919, and was granted an interlocutory decree of divorce on January 16, last. This decree was not to become final for one year.

JUGOSLAVS ACCEPT U. S. LOAN

Banking Syndicate Offered \$100,000 At 8 Per Cent Interest.

Belgrade—The Jugoslav government has accepted the conditions of an American banking syndicate for a loan of \$160,000,000 at 8 per cent interest, is due in 30. The money will be expended in the improvement of communications.

Washington—Appointment of L. G. Nutt, former chief of the narcotics section of the internal revenue bureau, as associate federal prohibition director for the state of Illinois, was announced by Commissioner Haynes.

London—Captain Herne, an aviator who arrived here from Paris, said that his machine had passed through a bolt of lightning without sustaining any damage. The aviator was not injured.

Second "Abe" Lincoln Dies.

Reading, Pa.—Alfred G. Lincoln, a former of Everett and a third cousin of President Abraham Lincoln, is dead here, aged 83. He resembled President Lincoln to such a degree he was known in his neighborhood as "Abe".

OFFICERS READY TO GET RUM CRAFT

PROHIBITION DIRECTOR DAVIS DECLARES WARRANTS ARE NOT NECESSARY.

BOATS FROM CANADA WATCHED

"Dry" Navy Will Make It Hard for Bootleggers if Judge Tuttle permits Searching.

Detroit—Federal Prohibition Director James R. Davis is not at all concerned as to the doubts raised about the legality of any seizures made on waters adjacent to Detroit by the boats he expects to put into commission this week to patrol the river and put down smuggling.

"If we have to come back to shore for a search warrant before we can seize a whisky smuggling craft, we might as well take off the boats," he said.

I hold that if we see cases that look like whisky on any river craft and it fails to stop upon signal, that is probable knowledge of the commission of a felony. If that is not enough we can take a customs officer with us and such an officer has a right to search any craft fitting in to the American shore. If he finds any contraband on board he has a right to seize the boat and arrest the crew."

"Probable knowledge" was the plea set up by the prohibition officers who seized John Draver's boat without a search warrant recently. At the examination before Commissioner J. Stanley Hurd, Deputy Prohibition Director Royal L. Decker testified that he had seen cases marked "whisky" on board the boat. This he claimed to be probable knowledge that a felony was being committed. The commissioner adjourned the case for a week to study authorities before giving a decision.

Judge Arthur J. Tuttle's decision that officers making a seizure must have a search warrant was intended to apply to seizures on land. At that time there was no boat seizure before him. Consequently, it is not known whether his ruling will apply to seizures on the high seas. Judge Tuttle is at present holding court in Bay City.

NEW BORN BABY FOUND SLAIN

Coroner's Jury Investigates Slashing of Infant's Throat.

Dowagiac—A new born baby was found with its throat slashed in an outhouse of the farm of Frank Nash, near here, Monday. It died a few minutes later.

FREIGHT RATE CUTS LOOKED FOR

Mr. Chicherin said that the Japanese government had agreed to withdraw its troops from Manchuria.



This means that any graduate may enter the University of Michigan directly without examination. Before a school can be accredited by the University of Michigan the following standards must be maintained by said school as judged by the University Inspector at the time of his inspection.

All teachers must be properly qualified.

The number of pupils per teacher based upon enrollment must not be excessive.

No Instructor in High school shall be required to teach more than six subjects per day.

The recitations periods shall be at least forty minutes in duration.

Sufficient materials and equipment must be provided.

The efficiency of instruction and the general intellectual and moral tone of the school must be high. Past students at the U. of M. must make good.

The program of studies must include sufficient units to enable a student to meet the entrance requirements of the U. of M.

The average of the class room work must be such as to entitle school to high rank.

The Northville school has satisfied all of these requirements and may well feel proud to receive this recognition, as the University inspection at the present time is a very rigid one. Prof. Edmondson recently sent a report showing that the majority of students of the Northville school made good records at the University.

Mr. Cody is a staunch American, and he made a strong plea for true Americanism and loyalty to our country's flag.


