

**PERFECT RECORD MADE BY PLANES ON ST. PAUL ROUTE**

Stinson Corporation Has Received Report of Winter Service

According to a report received yesterday from the Northwest Airways Company, by the Stinson Aircraft Corporation, there has not been a single forced landing of one of the Stinson planes purchased by the company early last fall.

The planes have been in daily operation since October first and in their flights between Chicago, Milwaukee and St. Paul have encountered all kinds of adverse weather conditions according to William A. Marz, business manager of the Stinson Aircraft Corporation.

The report shows that on 772 of the flights made by the planes aviators encountered storms, fog and blizzards. On three different trips between Chicago and St. Paul weather changes varied from 45° to 90° in 60 minutes. If the temperature continues sat nothing less than remarkable that there has not been a forced landing.

Mr. Marz adds that on 6800 miles flown by these planes, the percentage Williaming per cent for the scheduled return, a remark may help to the reader.

In St. Paul where the planes encountered the most severe conditions, the ice was about one-half inch thick, and the water was deep. The two airports were open on the field, on runs east and west, the other north and south. Aviators have written us that it is like landing in an open tunnel. 



## MICHIGAN

The editorial writer of the Detroit News Gazette saw the sun come out in grand dog day, and took his pen in hand. The following is what he wrote:

Michigan, My Michigan! In his attempt to shield your great lumbering, Nor is he

Michigan, filled with great achievements past and present. It is just a tribute to Michigan, a state which has a part of the little

contented, a state of mild introversion.

California has its plague of mice, Michigan, with fleas the men of fertile our-toms and in resultant loss of millions of dollars in life and property. Pennsylvanian is a man nation, states, business not culture and the west coast for earth quakes.

While other sections of the country were favored by pathogenic and healthy lands for their wear around summer climate are meeting difficulties Michigan continues to receive the continuous smiles of the gods.

In summer, unmeasured forests and streams and thousands of miles of shining highways offer a sanctum of rest and pleasure to thousands of work weary vacationists from every section of the United States and Canada.

In winter, her people a hardy race—not hot house plants these—glory in the stimulating atmosphere of freezing cold. And perchance the mercury tumbles to sub-zero depths, her children only smile the more while young and old with glowing cheeks and sparkling eyes delight in the wealth of winter sports.

Michigan, hot in summer, cold in winter, but Michigan—a climate where healthy people live healthy lives, raise healthy children and live to a healthy old age in surroundings unsurpassed for their educational and cultural opportunities.

## NOT SO ROSE

Albert S. Stoll of the Detroit News probably knows more about conservation for writers in Michigan than any other man in the state excepting E. Director Smith. A few days ago Stoll in a brief note pointed out some of the difficulties regarding the new director. He said:

Michigan, the director of conservator is doing out that timber and fish affairs are cleaning the major portion of its time, and that most of the areas to be decided are of a trivial nature when considered in connection with fundamentals of a constructive program.

First comes a delegation from some country above the Straits with the request that they be allowed to hunt rabbits in a territory closed to all hunting; another does up from the southern counties of the state asking that the ban be lifted on the spear in taking fish; another from the western districts requesting that they be allowed the use of weirs in seeking a permit to use a

shall set forth his name or legal title, and place of business, and submit therewith the permit issued to him by the Council and pay the license fee hereinabove designated. When the said applicant is an employing or master plumber he shall also execute and submit, along with the said application a good and sufficient bond in the penal sum of one thousand dollars, with two or more sureties, each of whom shall justify in real estate situated in said Village of Northville in a sum equal to the amount of said bond, over and above all indebtedness; and all exemptions from sale on execution or furnishing of bond of an approved surety company.

The bond shall be conditioned as follows:

That the licensee shall be a licensed master plumber of the Village of Northville, thereby undertaken and agrees strictly according to the rules and regulations of the said Village of Northville in force or to be in force hereafter, and subject at all times to inspection by the proper agents of officials of said Village of Northville. That said licensee herein undertakes and agrees to save, garnish, and indemnify the said Village of Northville from any and all claims, charges or liability, losses or damages, actions and judgments and executions of whatever nature or nature they shall or may at any time arise, come or be brought against the said Village of Northville in reason of any injury, losses or damages sustained by anyone, either by person or property by reason of through any imperfect or improper work or neglect of said licensee or by him or through any licensee or for unit materials used in the work of him, from or through the neglect or failure of said licensee to properly and effectively guard and protect any excavations, piles or material or dirt along or upon any streets, alleys, avenues, common or any public place, caused in performing any work undertaken by virtue of said license.

The following license fees shall be charged and paid to the Village Clerk in accordance with the provisions of this ordinance:

Employing or master plumbers twenty-five dollars (\$25.00) per year.

Journeyman plumbers two dollars (\$2.00) per year.

That said licensee when an employe master plumber shall immediately upon the completion of any work undertaken by virtue of the license report to the President of the Village of Northville, the condition of said work and that the same is ready for inspection by the proper official of said Village, and shall cause said work to remain in the condition as when reported for a period of at least 24 hours for such inspection, and if such inspection shall not be made, shall after the expiration of said 24 hours will and truly replace, restore or renew our portions of payment, with cross-walk, curbing, or sidewalk, or otherwise turn up disturbed terrain or incarnured by reason of the said licensee that the same might be and remain in braced condition satisfactory to the said Street Commissioner of said Village.

That said licensee, his agents and servants shall and will at all times comply with the provisions of all and all ordinances of said Village of Northville relating to the use of streets, alleys and public places and all ordinances and other regulations of the General Board of the several boards of the Village, including for the quiet and effective protection of aviation and the use of playgrounds so made and arranged in such manner as to prevent any accident, injury or damage and shall and will erect and maintain a good and sufficient fence railing or barrier around any excavations or piles of material so made as aforesaid, in such a manner as to prevent any accident, injury or damage and shall and will maintain upon such railing fence or barrier suitable and sufficient red lights during the hours of the night.

Upon receipt of the license fee as herein specified, the Village Clerk shall issue a license to the said applicant, the said license not to be and remain in force for a longer period than one year from its date of issuance, and all such licenses shall expire on the first day of May next succeeding the date thereof.

Third, The form of a plumber's license shall be as follows:

TO WHOM IT MAY CONCERN:

This is to certify that:

as aforesaid plumber has fully complied with all of the requirements of the state law and having passed a satisfactory examination is hereby duly licensed to build connecting sewers and to do all kinds of plumbing work in buildings for the discharge of sewage into or through the city sewers or otherwise until the first day of May, 1922.

Annual License \$1.00.

IN WITNESS WHEREOF I have hereunto set my hand and caused the seal of the Village of Northville to be affixed this \_\_\_\_\_ day of \_\_\_\_\_ 1922.

Village Clerk

I, \_\_\_\_\_, the Village Clerk shall pay all fees collected to the Village Treasurer.

Fifth, Any violation of, or wilful neglect or failure to comply with any or the provisions of this ordinance shall be cause for thereof to be punished by a fine of not more than one hundred dollars and costs of suit to be taxed by the court or by the sheriff in the Detroit House of Correction for a period of three days or both fine and imprisonment and on the imposition of any such fine, the court shall have power and authority to make a further order and judgment that any such person so convicted shall be imprisoned in the common jail aforesaid until such fine and costs shall be paid; but such imprisonment shall not exceed thirty days.

(As Amended)



#### TO SPEND BIG SUM ABOUT NORTHLVILLE

Another Toll Cable to be Put up at Once Says Local Manager

Plans for the immediate construction of a second large telephone toll cable between Dearborn and Detroit carrying circuits to a number of nearby and distant points have been announced by R. E. Crowe, Michigan Bell Telephone Company manager here. Very heavy increase of the use of the telephone circuits between the outlying towns and Detroit makes the addition to the interurban telephone toll plant necessary, Mr. Crowe states.

Six years ago the present toll cable was placed from Detroit to Dearborn, and contained 231 pairs of wires. It was expected then that the cable carried sufficient circuits to care for the service needs between Detroit and Dearborn and the cities north and west for several years, but development in the territory has exceeded expectations.

Besides carrying circuits between Dearborn and Detroit, the cable forms the Detroit gateway for long distance telephone service from Howell, Jackson, Romulus, Northville, Plymouth, Wayne and Ypsilanti. During the past year the cable was extended from Dearborn to Ypsilanti and Ann Arbor, Plymouth and intermediate points, and this year will be built to Jackson on its way across the state. Investments in the cable to date total more than a million dollars.

From the Bell building at Cass and State streets, Detroit, the new cable will be placed underground in Cass and Michigan avenues to the western village limits of Fordson, from where it will continue aerially. The distance of the cable run is ten and a half miles.

Manager Crowe says, the new toll cable will cost in the sum of \$100,000, and that the cost of construction will approximate \$105,000. Delivery of the cable, which is being manufactured by the Western Electric Plant at Chicago, is expected to begin this month. The new circuit will be in use before the close of the year it is anticipated.
