## Novi Township Takes First Step in Protecting Bad Crossing

Incumbents Litsenberger and Lawrence Opposed for Clerk and Treasurer Jobs; Name Election Board

Polls Open at 7 a. m.

With contests in two major Northville township posts creating interest and keen competition in the primary election which will be held Monday, Feb. 19, a heavy vote at the polls is anticipated.

For the clerk post, John Litsenberger, incumbent, is opposed by Fred W. Lyke on the Republican ticket. Adolph G. Balden, democrat, is also seeking the clerkship.

The treasurer's post has brought three-way competition among republicans drawing Mrs. Leo (Mollie) Lawrence, Mrs. Al (Ina) Bauman and Mrs. William (Louise) Saffora.

Republican Willard Ely, incumbent, has competition from Democrat A. L. Sheppard for the supervisor's job.

Justice of peace positions are sought by Bert C. Stark, democrat, and Alton F. Peters, republican.

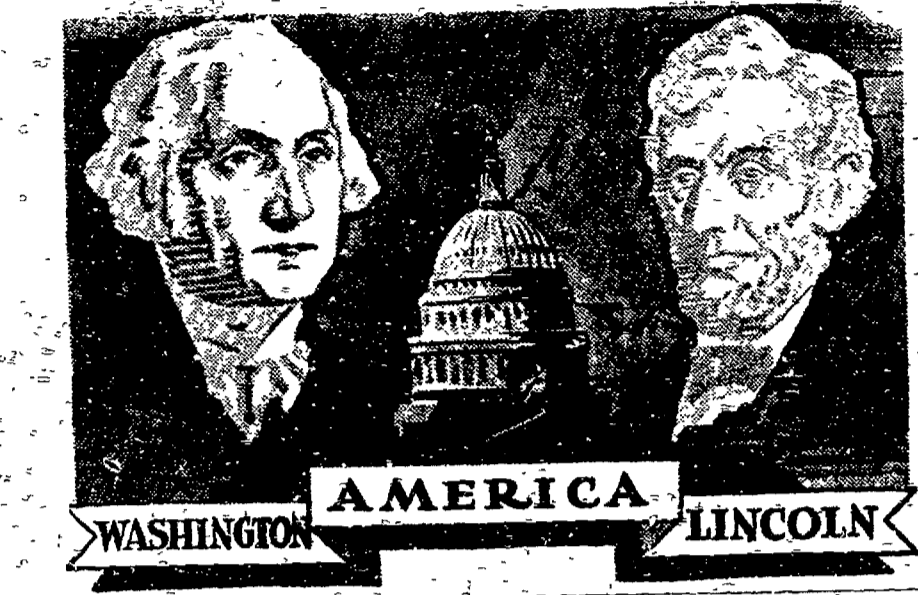

**Glib Salesmen Sell Poor Chicks**  
 Glib promises made by unknown chick salesmen will never fill many egg cartons, warns Ray Conolly, field manager of the Michigan Poultry Improvement association which has headquarters at Michigan State college.

Poultrymen in the State soon will be in the market for approximately 20 million baby chicks,—a field for sales that has been attracting more and more unreliable salesmen whose tactics arouse the ire of Manager Conolly.

He'd like to warn every Michigan flock operator to beware of strangers, especially those who offer "double star" or "triple star" or "superior" chicks from stock with all high pedigrees that "will lay up to 300 eggs in a year."

Egg production is an inherited characteristic, therefore the breeding of the stock is more essential than promises of salesmen. Beware, says Conolly, of unwritten offers of free flock service, free culling, gifts of free chicks, or remarkable or an offer to install brooding equipment at cost or without down payment.

"Most of Michigan's reliable hatcherymen do not have salesmen on the road. If they do, the representatives are fully authorized as dealers in the community in which they work," Conolly warns.

"Reliable salesmen do not make rash promises. The most protection for the poultryman is to have written statements, signed by the salesman and to keep copies of the order, price list and catalog. This can help in ridding the State of inferior chicks along with inferior salesmen."

The following letter has been received by the Rev. Dr. T. W. Smith of the Presbyterian church from Arthur Vandenberg:

Feb. 5 1940  
 Rev. Thomas W. Smith,  
 First Presbyterian Church,  
 Northville, Michigan.  
 My dear Mr. Smith,  
 This will reply to your letter of Feb. 2.

I am glad to know your point of view. I personally favor an effort to arrive at a new treaty understanding with Japan which shall unambiguously and adequately protect all legitimate American rights in China and which will thus justify a continuation of uninterrupted trade relations with our third largest export customer. If we do not come to some such agreement the results are not calculated to be attractive. If we apply a one-sided embargo of Japan we shall inevitably invite reprisals which may become so offensive that they must be resisted by force. Then, we are in the war ourselves. I do not care to take the "first step" in this direction unless and until we are deliberately and consciously ready to take the "last step" and, of course, none of us are ready to take the "last step." Furthermore, I think we must exercise some care that by arbitrarily depriving Japan of all American markets we do not force her into the arms of Russia and

thus solidify a dangerous threat not only to China but to the entire world.

My personal sympathies completely agree with your own in connection with the Jap-China situation. But we cannot rest American foreign policy exclusively upon our personal sympathies. At all times we must consult the ultimate peace and welfare of our own United States. If it proves to be impossible to write a new treaty which meets all of our requirements, then we can consider the alternatives. But I respectfully submit that the first effort should be to try to negotiate a new treaty.

I am very glad to have this opportunity to exchange views with you.

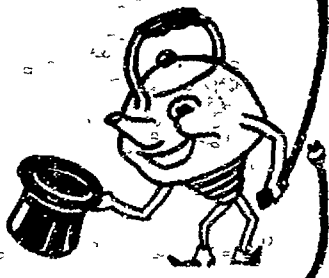

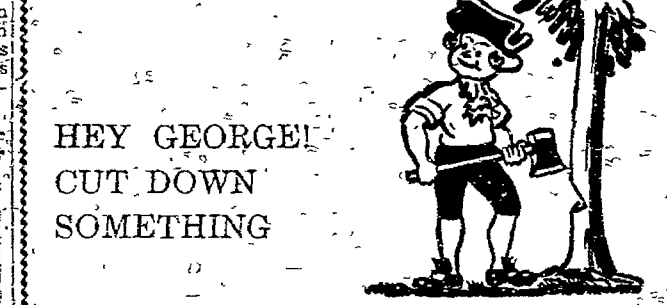

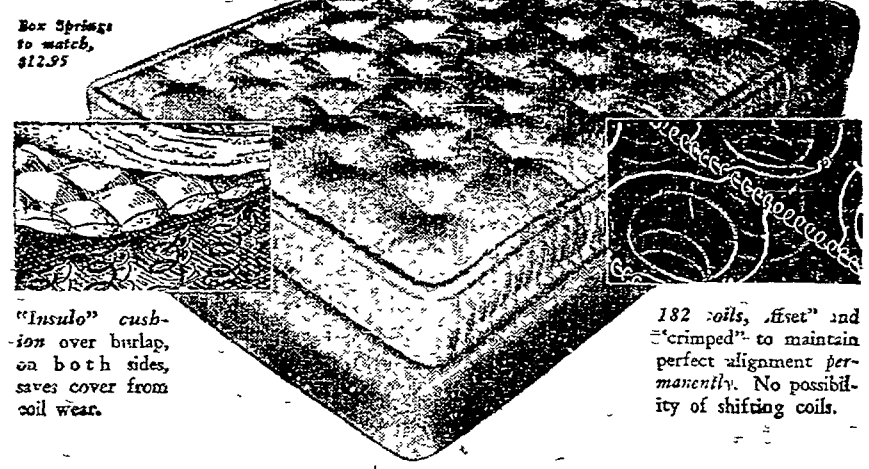

The largest fee ever collected by Lincoln was \$5,000. His estate was about \$200,000 for "Honest Abe" had a passion not for money but for honesty—he held a horror of debt—

which with the 44 billion dollar national debt of today seems to be out as the philosophy of America.

Presenting his thoughts, often in the words of Lincoln, and with several Lincoln letters and signatures which were shown, Dr. Smith made a profound impression upon the local club.
