"They kick about wages and squeal about hours, strike, threaten to strike, tie up machinery, and there you are . . . The people wanted soldiers—millions of them. Yet every day it's becoming apparent that many of these same people think more of a few cents an hour than they do of their own children and relatives."

It is interesting to know what young men who are serving their country in the army for less than a dollar a day think of the highest paid workmen in the world who threaten to block defense production unless they are paid still more. How much longer will the American people stand for this form of sabotage?

**HANDS AND FISTS!****News from Walled Lake**

A resolution by the Walled Lake board of education, made at its regular meeting Monday evening, will ask voters of the school district to pass on the transfer of \$34,000 from the general fund to the building fund, at the annual school meeting to be held at 8:30 p.m., June 9.

It is proposed to use the money for construction of a four room addition and alterations to the Walled Lake building.

Bids on the proposed construction opened at Monday night's meeting placed the approximate cost under \$33,000 for the building program now being considered. Considerably more than this amount is available in the general fund, at present, it was reported. While the estimated cost for the current project is somewhat higher than for similar construction in the past, it is not considered excessive, due to added provisions required in construction of the proposed unit. Other business transacted at Monday's meeting included purchase of a new, 32 passenger school bus as a replacement in the bus fleet. Election boards were also named to act in the June 9 school election. They are Mrs. Clara Stoltz, Mrs. Parthena Paup and William Hoyt at the Walled Lake building; J. Cecil Cox, Mrs. William King, and Earl Garner at Commerce; and Claude Lawrence, Mrs. Edwin Fleck and Albert Richardson at Union.


