Local Gravel Industries Help Maintain Living Standards

One of Northville's leading industries, which helps to establish and to maintain the standard of living of many a village, is the gravel pit business. The local gravel pits, which represent part of Michigan's natural resources, furnish sand and gravel for cement in buildings, sidewalks and streets; making a direct contribution to living, business and transportation in and near Wayne County.

Major gravel pit concerns in this area are Heichman and Van Every, Manning and Locklin, Northville Sand and Gravel Company, President and General Manager.

Heichman and VanEvery, on W. Seven Mile Road, was organized in April, 1942, by Elmer Heichman and Charles VanEvery. This industry employs 25 to 30 men and hires 10 trucks and drivers.

Besides its own products, the plant sells sand and gravel produced at the Harry-Pickett pit. The annual business averages between 200,000 and 250,000 yards of sand and gravel, sold mostly in Wayne County, with some sales in Oakland and Macomb Counties, covering an approximate area of 35 miles.

The Heichman and VanEvery pit covers 48 acres. It operates from March to December. They keep a stock of 15,000 to 20,000 yards depending on the demand.

Manning and Locklin is located south of Eight Mile Road and east of town. It was organized in 1926 by Charles Locklin and John Manning, and was moved to its present location in 1935, where it is operated by Locklin and Terry Manning, son of John Manning.

This firm employs 18 men and hires 15 trucks. It produces and sells 300,000 yards of sand and gravel annually, serving Wayne County with 95% of their business and dividing the rest between Oakland and Washtenaw Counties.

The pit, covering 250 acres, is worked 25 feet below water, which begins 40 to 50 feet below ground, on the Eight Mile Road side. Their stock piles, 3 gravel and 3 sand, hold 50,000 yards.

To the Editor

July 27, 1948

To clarify the issues at stake at the Monday, July 12 hearing of the Village Commission, I would like to make this statement.

The Commission has for years called special meetings by telephone to carry on normal functions of the Village but never to start proceedings to amend or change or adopt an ordinance.

At the Monday night hearing Commissioner Locke, when asked, stated that the Village Commission itself petitioned itself to hold a special meeting on Wednesday afternoon, June 23 to start proceedings to change the zoning classification on the race track property (of 1887). I said I did not understand how the Village Commission could so petition itself when it did not own the property in question.

After considerable discussion and time at this meeting Commissioner Locke changed his answer and said that the Northville Downs was actually the petitioner.

Was it necessary to call a special meeting on June 23 to start proceedings to amend the Zoning Ordinance in view of the fact that a regular meeting of the Commission was scheduled for the following week?

Then on Friday, July 23, the Commission saw fit to call another special meeting to amend the Zoning Ordinance. This meeting was entirely out of order as Section 18, paragraph 62 states.

No vote of the Commission can be rescinded or reconsidered at a special meeting unless the full Commission be present. There was not a full Commission at the above meeting.

Again on Monday, July 26, the Mayor and Commission, having discharged the Zoning Board of Appeals, proceeded to act as same. A vote was then taken to grant special permission to install a trailer camp on South Center Street, completely disregarding the regulation of the 21 day stay before an ordinance can become effective. Commissioners Locke, Stenberg and Schultz voted "yes". Mayor Langfield said he "passed" but changed this to "yes" after the attorney for the Driving Club called his attention to the fact that 4 votes were required to pass the motion.

They then proceeded to act on the Driving Club's petition requesting permission to repair and enlarge certain parts of the buildings at the race track. After much discussion both for and against, Commissioner Locke, Stenberg and Schultz voted "yes". Mayor Langfield said it was confusing that he also would vote "yes".

I wonder if a private citizen would receive all the above favorable attention? What do you as individual citizens of Northville think?




