Schools report new COVID-19 numbers

Sixty-three students and staff members in Huron Valley Schools were listed in quarantine last week after showing COVID-19 symptoms or being in close contact with a COVID-19 positive individual.

The number contrasts with two other numbers listed on a new COVID-19 dashboard on the district's website: a 3, for the number of confirmed positive COVID-19 cases in students and staff since school for the year and staff in close contact.

The dashboard is also a contrast with how other districts, including Novi, South Lyon, and Birmingham are relaying information in compliance with a

"The 63 quarantined is for a variety of reasons," district Communications Director Kim Root said, adding that the 63 could have been quarantined for any period of time between Oct. 4-10: the whole week or a few days, and could have been a continuation or start of a

Collin Anglin started watching the Ultimate Fighting Championship with his dad in sixth grade. He had been a wrestler well before then, saying his father had put him in wrestling shoes since he could walk. But

with the UFC, it was different. There was that voice in the back of his head that consistently told him, "I would love to do that."

It was a dream. But moving from South Lyon to Kalamazoo to attend community college, the dream quickly became a goal with one phone call.

Groups aim to make Northville a destination

Northville will not drown in stagnancy if first-year mayor Brian Turnbull has anything to say about it.

Emphasizing the urgency to change the historic city's trajectory, if only gradually, while praising the work of its

planning commission, Turnbull announced the creation of three mayoral task forces during an Oct. 15 town hall.

"If we don't act now, Northville will have one of the oldest populations in the state," Turnbull said. "These are ideas that can help attract families, young and old, to our city and make it more of a destination point for people."

The task forces' missions will focus on: ensuring that Ford Field evolves into a central park; eyeing a potential river walk that runs parallel to the city's waterways; and guaranteeing a vibrant future for Northville's farmers' market.

Trump fans at Novi rally share insights

About 200 people attended a rally Oct. 13 for President Donald Trump at the Suburban Collection Showplace in Novi, with the president's son, Eric, headlining the event.

Eric Trump took to a ballroom podium at about 12:15 p.m., and spoke for about 20 minutes to the crowd.

He began with remarks that taunted Joe Biden and the Democratic Party which he said wanted to abolish police, take faith away and keep churches and schools closed, and claimed that if President John F. Kennedy, a Democrat, was alive today, "he would 100% be on this team."

Eric Trump praised his father as wanting the greatest military in the world, bringing the lowest unemployment, decreasing drugs and illegal immigration and improving retirement accounts.

"We're gonna win this thing, we love the American flag, red, white and blue, love the Pledge of Allegiance and national anthem, we're not kneeling for the national anthem," he said to cheers from the crowd. "We're going to restore faith in this country."

His remarks resonated with David Reid of New Hudson and his friend Jackie Whybra of Highland Township, who upon leaving the event called it fun, although Reid said there wasn't as many people as he expected, which he attributed possibly to it being moved from the original planned location at Huron Valley Guns in New Hudson.

"I liked the message and he hasn't changed the platform of lower taxes, improving employment and the economy, and assisting minorities out of poverty," Reid said.

Prior to Eric Trump's arrival, rally attendees shared some of the same sentiments when asked what brought them to the rally, while they offered some additional insights about themselves:

with a name on the ballot in the November general election. However Marjorie Banner is seeking to retain the seat, running a write-in campaign against Lundberg.

Below is information shared by the candidates prior to the primary election.

Banner, who has served Northville Township in several roles since 2000 (she was a trustee from 2000 to 2012, treasurer from 2012 to 2019 and is currently the township's clerk), formerly wrote for ALM Publications. She earned a Bachelor of Science degree in journalism, education and political science and has a paralegal degree.

Lundberg is a 71-year-old automobile industry professional with 35 years of experience in director level positions. He earned a Bachelor of Science degree in engineering from the University of Michigan and a Master of Business Administration degree from U of M. He has been a Republican precinct delegate since 2012 and a member of Wayne County's 11th Congressional District Republican Committee since 2016.

Why are you running for office?

Lundberg: I've been married to my loving wife for 49 years. We have two sons, (3 grandsons) who live nearby. We have lived in the Northville-Plymouth area for the past 40 years, and moved to NHGC community in 2005. We love Northville, the people, the schools, the community, the amenities and a first-class public safety department. We feel safe. I am running because we love

Northville and want to keep it that way.

Banner: I believe I am the best-suited for a four-year, full-time position as clerk, due to my township experience, institutional knowledge, training and accreditation as clerk, my excellent work ethic and common sense approach to governing. I enjoy serving residents of the township and engaging with volunteers, of which there are many. I believe honesty, transparency and communication are essential elements of elected officials, and I provide all of those.

What are your top priorities for the township in the next 4 years?

Lundberg: First is developing the appropriate response to the COVID-19 crisis, as previously addressed. Second, is addressing the trash mountain in our back yard or the Salem Hills landfill. This negatively impacts the quality of life of many Northville Township residents and negatively impacts property values. This will require a multi-faceted approach, working with all levels of government and with the Conservancy Initiative — improving enforcement to assure compliance, using social media where appropriate, and supporting new legislation.

Banner: Stabilizing the effects of this pandemic and economic challenge, prohibiting expansion of the landfill and making it comply with EGLE and EPA orders, thus eliminating the odors emanating into nearby subdivisions and destroying residents home values. We must also continue with our plans for MITC to expand our commercial base and provide a better tax base for the township. I would like to continue the opening of our 7 Mile park, remove as many buildings on that property as budgeting will allow, maintain the exemplary services of our public safety department, and expand our parks & recreation and senior services offerings.

Why are you a better candidate than your opponent?

Banner: I am a better candidate because I understand that it is a full-time position, with the primary statutory requirement of providing safe, secure and accurate elections. So far, my opponent has not attended a BOT meeting or visited our department to see what we do. I am committed to working the hours necessary (80 hours/week during elections), expanding clerk's hours to serve residents, and will continue the necessary certifications to be proficient at my job. I enjoy serving the public and will provide all the essential and non-essential services required to run the department.

Lundberg: I'm a true Republican and believe in conservative Republican values. I'm a fiscal conservative and will fight to hold the line on taxes while protecting the public safety and parks and recreation services. I will fight to reverse the 1% administrative fee on tax collections (levied in 2017 without voter input). I'll challenge the excess "Rainy Day" fund levels, and I'll not seek to further increase rainy day funds through unnecessary tax increases.

Is there anything else you'd like to share?

Lundberg: It's time for a change. I'll bring a fresh perspective to the board of trustees. I've been a leader all my life, a team builder, an independent thinker with a strong work ethic. I wish to continue to serve our community, and ask for your vote on August 4.

Banner: I would like the public to know that I perform all my tasks to the "nth" degree and serve with honor and integrity. Northville Township is my home, too, and I want it to be the best that it can be.

Green Oak church hit by COVID-19 outbreak

A Green Oak Township church has temporarily suspended in-person services due to COVID-19 cases among its congregation.

The Brighton Assembly of God in Green Oak Township has been identified as a potential exposure site by Livingston County Health Department officials. "As of today, 14 unrelated individuals who tested positive for COVID-19 reported attending services at Brighton Assembly of God on October 4, October 7, and October 11, 2020. The positive cases are residents of multiple counties including Livingston, Washtenaw and Oakland," county health officials said in a Friday release.

Officials say people who attended church services on those days or participated in church-related events or social activities are at an increased risk for developing COVID-19.

"Due to the high rate of transmission and an increase in COVID-19 cases among attendees of Brighton Assembly of God, LCHD highly recommends CO-

VID-19 testing for all individuals who attend the church, whether they have symptoms or not," health officials said in the release.

"In addition to getting tested, LCHD recommends that individuals who develop symptoms immediately isolate and contact their primary care physician for guidance."

Church pastor Bradley Trask posted a video Friday afternoon on the church's Facebook page. In the video, Trask informs his congregation that church services will be live streamed online Oct. 18-25. He could not immediately be reached for comment Friday afternoon.

Trask said in the video the county health department notified him Thursday of cases among members of his congregation and he discussed what to do with a health officer. "She assured me, you and the church have done nothing wrong and that we could continue meeting in person. However, after concluding my conversation with her, I felt for the safety of our church and the greater good of our community it is best for us to move to an online format for the next two Sundays," he said in the video.

Detroit Mercy to open 1st campus outside city

The University of Detroit Mercy will open a new branch campus in Novi, marking the first time in its 100-year-plus history it has done so outside Detroit.

The private nonprofit university has bought the former home of South University, a private for-profit chain headquartered in Georgia.

The move isn't a signal UDM is looking to get out of Detroit, but rather a chance to get a building already set up for the type of spaces it will need as it launches new health-related programs of study, its president told the Free Press.

"We're not leaving the city of Detroit," UDM President Antoine Garibaldi said. "This (building) just checked off all the boxes. It was really tough to decide to go outside of the city of Detroit. There just weren't the right locations in the city of Detroit."

The new 40,000-square-foot facility is at the intersection of 12 Mile and Meadowbrook roads. It comes with classrooms, offices and everything UDM needs to jump right in, including a parking lot with about 250 spaces, Garibaldi said.

In it will go programs for various health profession sections. It also will allow UDM to start some new programs.

The university is seeing high demand in health care related fields, including a master's of nursing aimed at people with a bachelor's degree in something other than nursing who want to become a nurse. That program could start this winter, but has already had nearly 100 people inquire about it.

The university is also in discussion with health care partners regarding prospective new graduate programs

and also expects to offer professional development programs, including continuing dental education, at the new campus.

The school isn't disregarding its main campus.

In February, just two months after completing the largest fundraising campaign in the university's history and exceeding its \$100 million goal by \$15 million, UDM announced a McNichols Campus renovation that will significantly transform it. That campus in northwest Detroit was originally acquired in 1922 by Jesuit President the Rev. John McNichols. The project will begin in mid-November with a revitalization and expansion of the student union.

In August, following an 18-month renovation effort, the School of Dentistry's new entrance opened to patients as well. This upgrade features a three-story glass atrium, terrazzo floor and four stained glass panels from the chapel built in 1941 on Mercy College of Detroit's campus.

Lord & Taylor closing eliminates 46 jobs in Novi

The recently-announced closure of one of the anchor stores at Twelve Oaks Mall will result in the loss of dozens of jobs.

The parent company for Lord & Taylor, 27650 Novi Road in Novi, sent a letter dated Oct. 1 to the Michigan Department of Labor and Economic Opportunity indicating approximately 46 jobs would be eliminated at the department store when it closes later this year.

The letter, sent in accordance with the Worker Adjustment and Retraining Notification Act, indicates those positions will be eliminated beginning Dec. 1 "or during the 14-day period beginning on that date," according to the letter from Le Tote, the company that purchased Lord & Taylor last year.

The company filed for Ch. 11 bankruptcy protection earlier this year, citing

economic issues around the COVID-19 pandemic and other challenges. It announced in August it would close all 38 of its stores and liquidate. The store at Twelve Oaks Mall is its lone store in Michigan after others closed last year.

Lord & Taylor joins several other major retailers to file for bankruptcy during the pandemic, including JCPenney, Neiman Marcus and J. Crew.

Lord & Taylor is open from 11 a.m. to 7 p.m. Monday through Wednesday, 10 a.m. to 8 p.m. Thursday through Saturday and 11 a.m. to 6 p.m. Sunday, according to the Twelve Oaks website.

The closure leaves one less anchor store at the shopping mall: Sears closed in 2019. With Lord & Taylor leaving, it leaves Macy's, Nordstrom and JCPenney as the lone department stores at the mall.

"These committees will take a look at what we can do better for the future of our city — not just for ourselves, but for our children and grandchildren, too," said Turnbull. "I've had a number of people approach me about wanting to get involved, so the timing is right to start looking at these projects."

A noted Northville historian, Turnbull said he would embrace the idea of returning Ford Field to its status as an activity hub.

"Ford Field is a great green space that is so close, yet so far away (from downtown)," Turnbull said. "At one time, that was the meeting place in town. That's where all the football games were played, there was an amphitheater set up, speeches were made there."

"I'd like to see Ford Field re-established as a central gathering space, creating a 'magnet' for families, young people and all those across the area, with inviting access, entertainment, educational events and cultural activities."

Turnbull shared renderings that offered glimpses of a potential new archway to the space and a more inviting walkway to help the area take on more of a Central Park-type feel.

With the redevelopment of Northville Downs looming in the years ahead, discussion about the future site — or

keeping it where it is — of the city's robust farmers' market is vital, Turnbull said.

"It's been one of the best farmers markets for the past 100 years and we need to make sure it stays that way for the next 100," said Turnbull, "whether it remains at its current location (just west of Northville Downs) or is relocated."

If relocation of the market is required, future locations could include the park area near the Northville Valve Plant and the Foundry Flask area on Ca-

dy Street, Turnbull shared.

The creation of a Northville riverwalk is another topic raised from time to time in the past 60 years, but has never come to fruition — a pattern Turnbull would like to see changed.

"Northville is an epicenter of rivers, so the creation of some form of riverwalk could help connect the city from Mill Race all the way to, potentially, Fish Hatchery Park," he said.

The potential for a riverwalk is heightened by interest from several partners in the city and the fact that the city currently owns several parcels along the rivers.

Daylighting the section of river that currently runs under the Northville Downs property is also a long-term goal, Turnbull said.

"With our bicentennial approaching in 2027, the time is now to start looking at turning these concepts into reality," Turnbull said.

2-week quarantine.

"If you come to school and have any COVID symptom, we are asking you to go home and quarantine. It could be you have a cough, a fever, multiple symptoms," she explained. "We ask you to contact your physician, explain the symptoms and (the doctor) advises whether to get a COVID test."

A student could be considered quarantined just until that doctor's note is returned, for example, with a reason such as allergies for the symptoms that were displayed.

Root said she will be updating numbers every Friday and said "this has been a quiet week."

Huron Valley started school with a hybrid in-person learning plan, one of the first districts in Oakland County to return to face-to-face instruction after all districts in the state went to remote learning in mid-March.

Novi tallies 14 cases, none this week

Novi, which began school Sept. 8, also returned with a hybrid plan. The

district is not planning to report number of students quarantined, Communications Director George Sipple said, but will be in compliance reporting new and probable COVID-19 cases on the district website, within 24 hours of learning of them. Additionally, it will be specified at which building positive cases were identified, and whether it was a student or staff member.

The district has had 14 positive COVID-19 school-associated cases so far in the 2020-21 school year. There are no new COVID-19 cases in students or staff members reported as of Oct. 12.

South Lyon's spreadsheet empty so far

In South Lyon, which started school virtually but just returned to in-person school, a spreadsheet is prepared on the district's website, but is currently empty, denoting no new cases since Oct. 11.

The spreadsheet will inform the public of the number of positive or probable COVID cases, at which building, and the date the district was notified by the Oakland County Health Division. It also has space for additional communications.

In an email, Superintendent Steve Archibald wrote, "We will begin reporting data as of Oct. 12 when the order

took effect. We do not have previous information compiled."

Birmingham has 8 cases in past month

In Birmingham, the district is releasing information on positive COVID-19 cases in paragraph form with bolded dates under "public notices" with the most recent example, the district reported a confirmed COVID-19 case this week: "On October 13, 2020, we were alerted to a positive COVID-19 case in an individual at Pierce Elementary. Symptoms began on Monday, Oct. 12, when the individual was not present in the school. Due to the onset of symptoms, OCHD has determined that no exposure has occurred at Pierce."

Birmingham also began the school year remotely, but recently began phasing in a hybrid face-to-face instruction plan.

The district also reports a probable COVID-19 case at Harlan Elementary Oct. 7; a positive COVID-19 case on Oct. 2 in an asymptomatic individual who was testing for the PSAT at Groves High School the day before; four positive COVID-19 cases on Sept. 24, from individuals at three different elementary schools and one Seaholm JV tennis participant; and on Sept. 20 in a Seaholm

JV football player.

The information does not always specify whether the case is for a student or a staff member.

Northville has 18 cases

Northville Public Schools identified 18 positive COVID-19 results since Aug. 23, a dashboard on the district's official website indicated last week.

The positive tests have resulted in the required quarantining of 122 people who were in close contact with the infected individuals.

The dashboard will be updated regularly, the district announced during its board of education meeting earlier this month, which was held via Zoom.

Three of the positive cases were affiliated with the girls varsity cheer team, resulting in the quarantining of 22 individuals.

Two cases each were connected to the girls pom program and girls junior varsity volleyball.

One positive case involving the girls high school cross country team required the quarantining of 43 people.

A staff member tested positive for COVID-19 at Cooke School, a center for special-needs students between the ages of 3 and 26, resulting in the required quarantining of 11 people.

out. It was just kind of a shot in the dark. I thought it would kind of be funny, you know, a funny story to tell.

"They called me back five minutes later and were like, 'We got you a fight at 145 pounds in a couple weeks.' I was like, 'Oh shit. OK.'"

With his father in his corner, Anglin, 18, tried to replicate what he had watched on TV against a 30-year-old with a boxing background. The first-time fighter won by unanimous decision.

After his first fight, Anglin's dream blossomed, taking his goal and eventually transforming it to reality.

Anglin, now ranked as the No. 1 featherweight in Michigan, earned a UFC contract after beating Muhammadjon Naimov in a unanimous decision at the 2020 Contender Series.

As he awaits his first fight as a member of the UFC, which he hopes will be either in November or December, Anglin is confident, not cocky. He knows the level of fighters he will face moving forward.

However, Anglin feels like he belongs right there with them, a mentality he has developed ever since he first entered the wrestling room at South Lyon High School.

Tough from the start

Brian Wilson remembers the first time he met Anglin.

The former South Lyon head wrestling coach saw the freshman as scrappy, gritty and having a bit of an ego, something that was quickly repressed by the seniors on the roster.

But he remembers Anglin being a fighter, something Wilson saw each time the wrestler took the mat.

"He brought a level of toughness that was really a big deal when you are trying to establish ourselves as a program," Wilson said.

In 2008, the first year of the Kensington Lakes Activities Association, Anglin showed off that toughness.

South Lyon was wrestling for a division title in a dual-meet at Northville. He was already up by seven points, and, according to Wilson, was visibly tired from the match.

"He could have very easily just held on for the win, but he heard his teammates just pushing him," Wilson said. "We were pushing him and he recorded that last takedown to win by nine. ..."

"We ended up winning that dual meet by one point, securing the division title."

Without a clear outlet to continue wrestling outside of college, Wilson was not surprised when Anglin found a home in mixed martial arts.

The coach said, especially in the early UFC, many wrestlers thrived on that stage because they didn't have to focus on the takedowns or wrestling aspects of the fight, and focused more on the hand-to-hand combat.

After Anglin transferred to Michigan State and joined Brighton-based Scorpion Fighting System in Brighton, he found success, continuing to take fights and coming out victorious.

Anglin had the opportunity to live the life of those he admired as a child. He loved combat, using it on the wrestling mat and on the ice as a hockey player. He loved the concept of UFC: being locked in a cage fighting another person in front of family, friends and, sometimes, the world.

"It's just you and him," Anglin said. "There's nowhere to go. It's game on."

Heading into each fight, Anglin said there was a different level of nervousness he felt.

Instead of fighting every weekend, wrestling four or five bouts each Saturday in high school, he was training months for a single match.

"You lose in wrestling: All right, big deal. You get them next match," Anglin said. "Fighting: Well shit, I just sacrificed everything for the past three months for that fight. It takes a lot out of you."

As Anglin fought more and more, his reputation grew with each knock-out, each win, and that nervous energy seeped into those around him. Especially his mother.

Becoming the example

Vicki Anglin watched her son continue to take fights and continue to win. She had a nervous energy about the unknown: about what would happen to her son in that locked cage.

She did the only thing she could think to calm down: she wrote former UFC champion Conor McGregor a letter.

"My kids laughed so hard," Vicki Anglin said about her letter. "I was like, 'I don't know how your mom does this. I'm a wreck,' blah, blah, blah."

"Of course I didn't hear back from him, but it gave me peace of mind that I could almost actually talk to another mom because I don't have anyone to talk to about it."

For her, the build-up was close to unbearable. As she watched Collin cut weight and prep for each fight, Vicki said she would get scared and not be able to sleep.

But the day of each fight, her mentality would change completely.

"The minute I see his face and he walks out into the ring, it's like I turn into a different person," Vicki Anglin said. "I see his face and I know he's going to do the job."

Heading into each fight, Collin Anglin said he has to trust himself: that all of

the hard work he had done up to that point had made him ready to win.

Anglin entered the rink in the Contender Series confident he was going to beat Naimov. Near the end of the first round, after he had figured his opponent out, he knew he was going to beat Naimov.

And when he did, earning the unanimous decision, relief swept over him.

"It's a weight lifted off your shoulders, just in general because it had been such a long, tough road for this fight," Anglin said. "This camp was a long camp and a really tough camp."

"As soon as the fight was over, I was like, 'Finally. It's over. You did your job.'"

After fighting in front of a nationally televised audience and UFC president Dana White, Anglin secured his dream, earning a contract, something that his mother saw coming from the moment he started taking fighting seriously.

Collin Anglin moved to Denver, Colorado, over the summer to train for his first UFC fight. And while his end goal is the same as other fighters in his spot — a world championship — Anglin's initial goal is much simpler: he wants staying power at the UFC level.

"I just want to have a successful run in the UFC," Anglin said. "I want to finish out my first contract successfully. I don't want to be in and out. I want to be in and stay in."

While Anglin trains over 1,200 miles away from where he first caught the fighting bug, Wilson says his former wrestler's impact is still felt in metro Detroit.

He sees Anglin as a pathway for young people who enjoy the physical nature of wrestling, who may want to use it even past the traditional path of collegiate competition with the goal to compete in the Olympic Games.

Because he converted his dream to a goal and a goal to reality, Anglin became an example for wrestlers in South Lyon and around an area that did not have a mixed martial arts presence when he grew up.

"Just having him as a focal point for kids," Wilson said. "If you come in and do the work, you can end up getting to good places."

Northville wins third-straight state title

The Northville girls golf team won its third-straight Division 1 state title Friday at Forest Akers East, shooting a 313 and beating second-place Rochester Adams by nine strokes.

The Mustangs clawed back, moving up from eighth place after four holes and fourth place after eight to continue its state title streak after beating Plymouth in 2018 and Grosse Pointe South in 2019.

Sophomore Samantha Coleman led the way for the Mustangs, shooting a 75,

good for sixth place, tied with two other golfers, in the overall tournament.

Sophomore Avneet Gill and junior Haesol Park each shot a 79, good for a shared 14th place, while senior Katelyn Tokarz shot an 81. Junior Megha Vallabhaneni rounded out the scoring for Northville, shooting an 81.

Northville head coach Christopher Cronin said the team does have extremely talented players, who are younger. However, he said the championship was a collective effort.

"As a team, the girls played their last

Churchill wins city championship

Coming out of the locker room out of the first half, Livonia Churchill knew it still had a battle to face.

Other than a 60-yard touchdown on his first carry of the game, Livonia Stevenson running back Caden Woodall had been unusually normal: recording 63 yards on his other 12 carries in the half.

And at the start of the third quarter, with the Chargers leading, 14-7, Stevenson began to slowly move the ball again. Starting at their own 37-yard line, the Spartans used the option, using quarterback Kyle Brown as a focal point of the offense, taking the ball four times for 25 yards.

But on a third down attempt, Brown fumbled and Churchill junior defensive lineman Demarius Gibson-Wells picked it up to thwart a chance at a Spartan

score.

Gibson-Wells' fumble recovery was the first of three turnovers in the third quarter for Churchill (4-1), allowing them to keep Stevenson (2-3) at arm's length when it counted in the fourth quarter to secure a 24-20 win for the Livonia city championship.

With 2:17 left in the game, Brown threw a 14-yard pass to the end zone that was tipped at the line of scrimmage, but landed in the hands of Stevenson senior

tight end Landen Macek for the score.

But Churchill blocked the extra point, retained possession on the ensuing on-side kick try and junior running back Boston Clegg Jr. took the ball three times for 27 yards to secure the city title.

"It's always good. It's the number one goal on our goal board every year is to be city champs," Churchill head coach Bill DeFillippo said.

South Lyon, Marian girls golf take home state titles

The South Lyon girls golf team won its first Division 2 state title Friday at Forest Akers West in East Lansing, beating three-time defending state champion Forest Hills Northern, by three points.

The Lions, scoring 335, were led by senior Katie Potter, who finished second overall, shooting a 73 — one stroke over par — while sophomore Gabriella Tapp finished sixth with an 80.

Senior Bella Campbell (85), junior Sophia Joseph (97) and junior Logan Faust (101) rounded out the scoring for the Division 2 state champion.

For South Lyon head coach Dan Skatzka, this title has been a long time coming, having led the Lions to a state final for 12-consecutive seasons, each time leaving without a trophy.

"We have been runner-up twice, and finished in the top five most of those years, but to actually win it all is very special," Skatzka said.

Farmington Hills Mercy finished in eighth place with a 367.

After Potter birdied the first hole, South Lyon stretched its lead to as many as 11 strokes. The senior posted two more birdies on the front nine, finishing three strokes under par after nine holes.

Canton claims KLAA West crown with Hartland win

Nothing about 2020 has been normal for Canton's seniors.

For the first time in three seasons, the Chiefs claimed the Kensington Lakes Activities Association West division championship Friday with a 49-28 win over Hartland on senior night.

"Feels really good. These kids will forever walk these halls and see a trophy in the athletic wing. They'll be a number on the banner for division championships," coach Andrew LaFata said.

Getting off to a hot start

The Chiefs (5-0) offense wasted little time building a substantial lead in the first half.

On the opening drive, Canton marched down the field through its ground game. Junior Wesley Faulkner busted free for a 47-yard touchdown that was called back on a holding penalty. Four plays later, senior quarterback Kaleb Burg attacked the Eagles defense through the air for a 36-yard touchdown pass to Faulkner for a 7-0 lead in the first quarter.

Hartland (3-2) gave the ball back on a three-and-out, and a muffed snap on the punt attempt, which gave the Chiefs

a short field. On the next play, Canton junior running back Zack Badger scored on a 24-yard run for a quick 14-0 lead.

After Hartland's defense made a stop with an interception by Carson Neuer, another bad snap prevented the Eagles punt team from getting off the punt. Canton turned the short field position into a 21-0 lead five plays later on a 15-yard touchdown pass from Burg to freshman Caleb Williams.

"Our goal is to get points every drive. Even if we get a touchdown, we look at the scoreboard like it's 0-0," Burg said.

The next Canton drive, the Chiefs scored on a 18-yard run by Burg for a

28-0 lead with 4:11 remaining in the second quarter.

Fighting back

Hartland fought back to close the half that was sparked by an interception by sophomore Chase Kern.

With less than a minute in the half, senior quarterback Holden D'Arcy ran the ball twice, before throwing a fade to Jason Hug for a 28-7 score with 28 seconds left in the half.

"We woke up a little bit at the end of the half. The kids got fired up knowing that we'd get the ball to start the second half," Hartland coach Brian Savage said.

D'Arcy led the offense on all six plays on the opening drive of the second half. Attacking through the air and the ground, D'Arcy had the Eagles in scoring position after a defensive pass interference penalty. With the ball on the 31-yard line, the senior threw the ball to Isaac Elmore just shy of the goal line.

The wideout caught the heavily contested ball on a basket catch, with a defender draped over him as they tumbled across the goal line for a touchdown, 28-14, with 9:54 left in the third quarter.

After a Canton three-and-out, the Eagles looked to make it a one-score game, but turned the ball over on downs just outside of the red zone.

Canton then went back to what it does best, and ran the football behind Badger and Marco Johnson.

"Second half, the kids said 'Let's just run the ball. Run it behind me,' LaFata said. "And when they do that, I just listen to them."

Seven run plays, including a huge 45-yard run by Faulkner, set up a 1-yard touchdown run for Badger for a 35-14 lead with 3:18 left in the third quarter.

The entire fourth quarter was a back and forth game.

The Eagles opened the quarter capping a 12-play drive in three-and-a-half minutes on a 2-yard touchdown run from D'Arcy. Canton countered on the next drive with a 15-yard touchdown run by Johnson. Then, sophomore Joey Mattord busted a long 63-yard touchdown run to cut back into the lead, 42-28 with 6:01 left in the fourth quarter.

Canton capped the scoring, 49-28, with Badger's third touchdown run of the game with 3:42 left in the game before both teams ran out the clock.

"Going through all the adversity we had to go through with COVID made everything different. Being Senior Night tonight, we knew it was going to be special for a lot of reasons," Burg said.

Up next, Canton will look to remain undefeated on the road against Plymouth.

Stopping Woodall enough

Over the past two weeks, DeFillipo said his defense has not played well.

After allowing 36 points to Franklin in Week 3, the Chargers defense gave up 27 points to Dearborn Fordson, allowing the Tractors to connect on a Hail-Mary touchdown pass as time expired to hand them their first loss of the season.

In the second-to-last week of the regular season, Churchill's attention turned to the Stevenson offense, who has scored more than 40 points in each of the past three games, much to the credit of Woodall, a Harvard commit, at running back.

"We knew we couldn't shut Caden down totally," DeFillipo said. "You just hope he wouldn't have five or six runs where he broke loose for touchdowns because he's a really good player and a great kid."

After containing him for one 60-yard touchdown run in the first half, Woodall broke free again in the fourth quarter, taking the ball 89 yards after the Churchill offense turned the ball over on downs.

But other than the two touchdown runs, Woodall was kept to 104 yards on 24 carries, including only 13 yards in the third quarter. He finished the game with 253 yards and two touchdowns on 26 carries.

"They focused on Caden, which was expected," Stevenson head coach Randy Micallef said. "We had a couple opportunities with counters and other stuff, and we shot ourselves in the foot. Once we got going, even that drive in the third quarter: eating a lot of minutes on the clock and then we turn the ball over inside the 40-yard line."

Clegg, a starting linebacker along with playing running back, said the Churchill defense watched film, and knew what to expect from Woodall.

Knowing he was going to get yards, Clegg said if the Churchill defense kept him from the totals he has put up this season — scoring 15 touchdowns in

three games leading up to Week 5 — Churchill would come out on top.

Turnovers helped too.

After Gibson-Wells' fumble recovery, Churchill extended a drive after junior defensive end A'Mareon Jackson picked up a fumble off a muffed punt, leading to a field goal that gave the Chargers a 10-point lead in the third quarter.

And on Stevenson's next offensive play, Brown fumbled the snap, and Clegg picked it up, nearly capitalizing on a 1-yard touchdown run that was called back because of a hurdle.

In the third quarter, the referees

called a stoppage of play after an altercation formed involving a line judge on the Stevenson sideline. The line judge was removed from the game.

Diversifying the offense

At this point last year, Churchill quarterback Gavin Brooks said the Chargers had to out-throw teams.

While that remained a focal point of the Churchill offense against Stevenson, with the senior completing 14-of-26 passes for 147 yards and a touchdown — an eight-yard touchdown pass to senior

running back Dennis White — Brooks did not have to carry the offense.

He had a secret weapon: Clegg.

The junior, in his first season as the starting running back, carried the ball 13 times in the second half, recording 118 yards including a 62-yard touchdown run to give the Chargers a 10-point fourth-quarter lead.

Clegg finished the game with 15 carries for 146 yards, catching one pass for -1 yards.

"Offensive line has been great opening up holes and our passes set up runs and our runs set up passes," Clegg said. "They think it's play-action: dump it off to anybody. They think it's pass: we run the ball."

For Brooks, Clegg's emergence has allowed him to open up the passing game, taking advantage of a crowded defensive box to find holes.

"Boston had such a great offseason and our o-line has been playing so well that we can kind of mix it up now and people can't rely on stopping the throw," Brooks said. "Now they have to respect the run, and Boston has had a hell of a season so far. He just adds that other dynamic that we needed."

With Clegg and Brooks at the head of the offense, using pieces on the outside including senior wide receiver Jordan Garcia, who recorded an eight-yard touchdown rush for the first score of the game in the first quarter, Churchill is confident that it is putting the pieces together to be a strong contender when the postseason comes.

And while Belleville stands in the way of a five-win season, Churchill is more focused on the fact that it had achieved its first goal: winning a city championship.

"Can't be more excited," Brooks said. "It's been a couple of years since we've had a city championship back at Churchill and it's really big for us."

Churchill will take on Belleville on the road in the season finale Oct. 23, while Stevenson returns home to face John Glenn.

Here's a look at what Hometown Life-area teams have in store for the final week of the regular season.

South Lyon East vs. South Lyon

North Farmington shuts down South Lyon

Heading into the first round of district play, North Farmington head boys soccer coach Erika Rust challenged her defense.

The Raiders had allowed 20 goals this season, including three goals in their last time out against city rival Farmington. She said the group was talented and hard-working, but, point blank, North Farmington had allowed too many goals in 2020.

Senior goalkeeper David Allam and the rest of the North Farmington (5-3-4) back line took that criticism and showed off, opening its playoff run with a 2-0 shutout against Lakes Valley Conference champion South Lyon (8-3-1), 2-0.

The Raiders advanced to the district semifinal for the first time since 2016, ending a three-game losing streak in the first round of the playoffs.

"I challenged them and they really stepped up tonight," Rust said. "They were locking down. South Lyon has some very talented forwards — I mean No. 6 was all over the place, along with some other guys. Our guys played them tight and I think took it to heart."

Defense steps up

South Lyon head coach Brian Elliott said the North Farmington defense was extremely direct, changing the Lions' normal approach of capitalizing off mistakes, building out of the back and try to lead possession.

Instead, the Raiders consistently went from their defense to forwards, using speed thwart any opportunity of a South Lyon offensive play.

"They have a lot of talent up top, a lot of speed up top that caused us problems," Elliott said.

And when South Lyon did find an opening, recording five quality shots on goal early in the second half, Allam was there to greet them.

After a 45-yard free kick by South Lyon senior midfielder Jean Gamboa hit the top-left crossbar for a near score, Allam stopped another scoring try second

later, swatting back a shot by senior forward Jack Voight with a dive to his left.

And when South Lyon sophomore forward Anthony Racka found a clear

lane for Gamboa, the senior's shot attempt landed right in Allam's chest.

Allam and the rest of the North Farmington defense recorded its first shut-

out since a season-opening draw against Rochester Adams.

"We talked about it at the beginning of the season, we had a lot of talent," Allam said. "I think it took us awhile to really get our chemistry, but today really proved we have chemistry, we have talent. Put those two together and you can really show out against a team like this. Doesn't matter who we are playing."

Raiders score just enough

As the defense shined, the North Farmington offense took advantage when it needed to.

Fourteen minutes into the game, junior Bryce Flynn poked the ball from the left side of the field into scoring range for junior Julian Marchionda, who shot in the top left corner of the goal, past South Lyon senior goalkeeper Shane Marinkovich for the first score.

With just over 16 minutes left in the game, North Farmington senior Josef Bass had a clear path to the dagger.

Beating two defenders, Bass streaked in the middle of the field on a fast break, preparing for a one-on-one attempt against Marinkovich, but was tackled 20 yards away from the goal by one of the defenders flanking him.

Bass connected on the ensuing penalty kick, juking the goalkeeper out and hitting left to give the Raiders a two-score lead.

Playing in the Oakland Activities Association Red division, Rust knew, coming into the playoffs, North Farmington was battle tested.

In the playoff opener, she felt the Raiders showed that level of resilience. And while the path out of the district is loaded, Rust feels North Farmington is on an upward trend, and may have a shot.

"This year, anything can happen in this district," Rust said. "Obviously you got CC and Northville, Novi: they are good schools. But we have been playing good schools all season."

South Lyon East cross country continues to make progress

South Lyon East senior cross country runner Alaina Rider remembers what the team was like when she first joined as a freshman.

"We were just kind of a team that went out and we ran," she said. "We didn't win any of our meets. We just went out and we tried to run as well as we could at each meet."

Through her first three seasons with the Cougars, Rider had only been a part of five dual-meet wins.

As a senior, Rider and the South Lyon East girls cross country team completely changed its course, using a youth wave on the varsity roster to begin the season with five-straight dual-meet wins, before losing to South Lyon.

Coming off a 1-7 season in 2019, South Lyon East assistant coach Erica Aitamma said that over the summer she saw the Cougars had talent coming in from their freshman class. There was already some potential on the roster coming from the Cougars' No. 1 runner: Lili Aitamma, who, as South Lyon East's only representative at the Division 1 state finals in 2019, finished 63rd.

But as the team started to run together, Erica Aitamma was unexpectedly impressed.

"I think we were kind of surprised," Erica Aitamma said. "Like over the summer, seeing some of the training, like, 'Wow, maybe this will work.'"

South Lyon East head coach Dave Testa said, even with the new players, the team was motivated through the summer. The runners stayed active, stayed fit throughout the quarantine period of the coronavirus, especially after the track team's spring season was canceled.

But Rider, as an incoming senior captain along with Abigail Bartlett, had the drive for South Lyon East to not continue on the path of her first three years with the program.

"I don't know if it was the whole COVID thing and not

being able to have a track season that we are all so much more motivated and now, we're like 'Let's go. This is our season,'" Rider said.

Rider began leading optional runs, reaching out to teammates and coaching the newer members, picking them up when they were down, being a motivator and a leader.

With the leadership of Rider and the talent coming in, including freshman Ella Showerman, who finished behind Lili Aitamma in all but two of the dual meets this season, there was a level of enthusiasm and competition that was unheard of for South Lyon East and the history it has had.

"Everyone had to get into the groove of things," Lili Aitamma said. "As we started getting more time trials in and seeing how fast everybody was, the competition and that last sprint to the finish, I knew the varsity spots were going to be hard to get."

"I think there is more enthusiasm to do better. We're all looking forward to the next meet. We know we actually

have a chance at winning."

South Lyon East proved that at the LVC conference meet, finishing in eighth place — the program's first top 10 finish in the race — with Lili Aitamma placing seventh.

Heading into the pre-regional Oct. 23, South Lyon East is excited for what could be, despite seeing rival South Lyon, LVC foe Walled Lake Western and reigning state champion Brighton in the race.

Testa, who has been with the program since 2015, remembers when the Cougars came into the postseason without excitement.

"Two years ago, we went into the regional meet and we came in last by a lot. I mean it wasn't even close. We were way back there," Testa said. "Leading up to that, we were like, 'Ooh, this is not going to be a very good time.'"

"Now, you go into that pre-regional like 'Hey, we're here and we're fighting for something.'"

Heading into her final stretch of races, Rider is thankful for how the team has impacted her on and off the track.

"To me, this team is everything," Rider said. "It's what got me through the whole corona. It's what I look forward to every day. And it's just such a great group of girls too."

But when Rider leaves, the expectation for the South Lyon East girls cross country program is to continue to grow. Testa said the ultimate goal is to qualify for a state meet as a team with all seven girls competing, not only one.

While that may not happen in 2020, Lili Aitamma is confident in where her team is heading.

"Our varsity team is completely different from the year before because of the competition," Lili Aitamma said.

"There's just more and more girls PR-ing and getting better."

"I think by the time I'm a senior, we will be even two steps ahead from where we are right now."

Northville boys cross country finishes runner-up at KLAA championship

Featuring five of the top 14 ranked teams in Michigan Division I boys cross country, Saturday's Kensington Lakes Activities Association meet at Huron Meadows Metropark turned out to be one of the most competitive in the state so far this season.

Taking three of the top eight finishes, sixth-ranked Salem won the 15-team field with a team score of 55, narrowly defeating No. 12. Northville (60), while No. 10 Novi scored 81 for third place.

No. 14 Brighton, the defending state champions, scored 106 to finish fourth ahead of No. 11 Hartland's 107.

"Salem beat us pretty good earlier this season," Northville coach Tim Dalton said of the dual meet between the two teams in which Salem swept the Mustangs. "I said then that I knew we were a better team than we showed and we gave them a run for their money this morning."

"They're a good team and they're well coached. They earned the win today."

Because of Michigan High School Athletic Association COVID-19 restrictions limiting the number of competitors,

the meet was split into two races: one of KLAA West schools and the other with KLAA East schools. Results from each race were merged to determine All-Conference finishes and the team champion.

Though this year's meet wasn't won with any photo finishes or much late-race drama, the KLAA West race began with some confusion among everyone in attendance.

Seconds after the race began, the race starter inadvertently fired his starter's pistol a second time as he was putting it away. The second cap shot, which typically signals a false start and for competitors to return to the start line, caused every runner to stop for a moment before the meet official instructed them to continue the race.

After the confusion subsided, individual state title contender Riley Hough of Hartland went on to win the 5,000-meter race handily in 15:19.

Jacob Meek led the way for Northville with a sixth-place finish in 16:15 followed by teammate Nathan Hayes, who took 10th in 16:29.

Northville's next three finishers, Matthew Krahe (13th),

Brandon Latta (14th), and Jake Bulat (17th), completed the team score and were within three seconds of each other, crossing the finish line in 16:34, 16:34 and 16:37, respectively. Max Uphaus (22nd, 16:39) and Brady Heron (28th, 16:48) rounded out the Northville lineup.

Each Northville runner finished the race with a season-best time. Six of those were career-bests.

"I thought we did extremely well," Meek said. "Everybody raced great. We had season bests across the board, and I think we just raced hard and raced with a lot of heart today."

With each Northville finisher placed in the top 28, all seven Mustangs earned All-Conference honors.

"I'm excited because we ran really well today," Bulat said. "This was probably the best team race we've had all season."

Due to the MHSAA's evolving schedule as the season progressed, the meet also served as the dual meet between Northville and Novi, with the Mustangs pulling out a 27-31 victory. With the win, Northville finished the KLAA West dual meet season in third place with a 5-2 record and Novi finished 4-3.

"Being in the KLAA West we are in one of, if not the, most competitive divisions in the state of Michigan," Dalton said. "There are some really, really good teams from top to bottom."

The Mustangs will compete in the MHSAA pre-regional meet Saturday at Novi High School where they will need to finish in fourth place or better in the field of nine teams to advance to the regional competition.
